RULES OF THE DRAW

1. ORGANISER

- 2.3 The Organising Body reserves the right, at its sole discretion, to decline to validate an entry that it considers to contravene the rules set out herein, without having to justify its decision.
- 2.4 Only one entry per person will be accepted for the duration of the Competition. All other forms of participation are excluded.
- 2.5 The Competition does not involve any prior expenditure by the participant of any kind. Consequently, no refund of any kind will be made by the Organising Body.
