1. THE DATA USER'S IDENTITY

2. WHAT IS A COOKIE?

When you visit any website, it may store or retrieve information on your browser, mostly in the form of cookies. If you do not allow these cookies we will not know when you have visited the Website, and will not be able to monitor its performance.

3.3 Functional cookies

These cookies enable the Website to provide enhanced functionality and personalisation. They may be set by us or by third party providers whose services we have added to our pages such as chat service or video player... If you do not allow these cookies then some or all of these services may not function properly.

3.4 Targeting cookies

These cookies may be set through the Website by our advertising partners including social networks. Please read carefully social networks' personal data and cookies policies.

The targeting/advertising cookies may be used by those companies to build a profile of your interests and display relevant adverts to you on other websites. They do not directly store personal information, but are based on uniquely identifying your browser and internet device. If you do not allow these cookies, you will experience less targeted advertising.

4. HOW TO ACCEPT OR REFUSE COOKIES?

You may at any time accept or refuse cookies via our cookies management platform.

You may also accept or refuse cookies by activating the setting on your browser via the browser's help menu.

Any settings which you may make will be likely to modify your navigation of the Website and may disable access to certain parts of the Website. Unless you have adjusted your browser setting so that it will refuse cookies, they will be issued when you access the Website.
